<u>Item 6 – Discussion, Consideration and Action Regarding Taylor County Sheriff's Office</u>
<u>Request for Certification Pay Increase for Telecommunicators</u>

Director von Wolffradt began by explaining this is a holdover from previous meetings. He and Sheriff Bishop have briefly discussed the increase and percentages that were reallocated to both PSAP operations. These new amounts will cover the certification pay.

Administration recommends denying this request because of it being covered elsewhere. Bob explained that Administration recommends moving the funding level to 63%, which will be discussed in Item 8 of this Agenda.

Boardmember Rice motioned to approve the denial of this request; Boardmember Pope seconded the motion. Motion carried.

Item 7 - Presentation and Acceptance of Annual Audit for Year Ended September 2021

Mike Rains, Finance Director, City of Abilene began by stating this was prepared by BKD of Dallas in conjunction with the city's audit. Rains went over totals for expenditures and revenues.

He noted the total revenue was an increase from the projected amount, and kept the balance positive.

Boardmember Rice motioned to approve item as presented; Boardmember Hoebelheinrich seconded the motion. Motion carried.

Item 8 - Discussion and Approval of the Revised FY 2022 and Proposed FY 2023 Budget

Director von Wolffradt began by stating that the major change in FY 2022 to FY 2023 budgets will be found in the level of reimbursement to both dispatch centers. He notes that this is a substantial increase from previous years and that 67% of total expenditures is going directly to both dispatch centers. He went on to say that this will be monitored over the next twenty-four (24) months. Also being monitored, is the line counts, for dramatic fluctuations. At that point, it would be brought back to the board for discussion of increasing or decreasing the reimbursement amounts.

Chairman Bush notes that it has been a goal for some time that Administration could figure a way to supply the needs of both County and City dispatch centers through funding from the Board. He notes that he's most proud that Administration did this and still has reserves for unforeseen issues.

Bob adds that with the flooding at the City PD location, and forced dispatch relocation to the shared backup dispatch center at City Hall, proved that it was sufficient fifteen (15) or more years ago. Due to growth in our jurisdiction, it proved to be ineffective. He states that there is contingencies set aside, even with the reimbursement increase, for the purpose of a different facility for backup dispatch operations for city and county. He will begin searching for facilities for either relocation or rebuild.

Chairman Bush asks about the 911 outages in the surrounding jurisdictions and states that he was unable to get more information. Bob states that details about that were not clear and he could not get a definite answer on what caused the outage.

Boardmember Pope motioned to accept the item as presented. Boardmember Rice seconded the motion. Motion carried.

Item 9 – Discussion and Approval of Setting the Emergency Service Fee for FY 2023

Bob began by stating historically, Administration has set fees by a percentage of AT&T base rates. In the last few years, AT&T has raised rates significantly. Therefore, Administration has calculated a flat fee of \$1.68 for residential, \$8.70 for business and \$8.70 for trunk lines. He adds that there has been a decrease in residential due to moving to cell phones but an increase in business and trunk lines.

Boardmember Rice motioned to approve the item as presented. Boardmember Pope seconded the motion. Motion carried.
